In connection with the subject, it is to inform that CIDCO had constructed 6 numbers of holding ponds near village Funde, Karanja, Bhendkhal, Pagote, Dhutum to hold the tidal water during high tide during the monsoon period to avoid the possibility of flooding in and around the above mentioned villages.

You have permitted to close the flap gates during monsoon period vide referred letter dated 05.05.2021. The copy of the same is enclosed herewith for your ready reference. Now considering the onset of the monsoon, we need to take the precautionary measures to avoid the flooding, therefore it is requested to grant permission for fixing the FRP flap gates to the pipe outlet structures of the holding ponds in Dronagiri Node during the monsoon period.
